

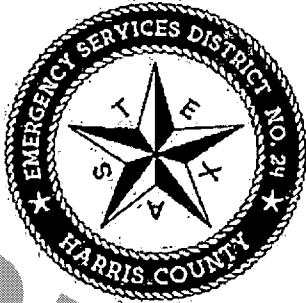
**PUBLIC MEETING NOTICE**

The District will consider and act upon the following matters:

1. Call meeting to order, roll call and establishment of quorum.
2. Join together in the Pledge of Allegiance.
3. To receive public comment.
4. To approve the Minutes of prior meetings.
5. To receive the Treasurer's report.
6. To pay District bills.
7. To receive a report from Martinez Architects and take action on District construction matters, including the approval of any pay applications or change orders.
8. To review and discuss the District budget and make any necessary amendments thereafter.
9. To receive Chief Parker's report regarding fire operations, rescue activities and personnel training sessions during the previous month.
10. To review and approve requisition requests submitted for the purchase or repair of equipment, supplies, materials, vehicles and apparatus.
11. To receive a report regarding social media and upcoming events from the Department's Public Relations and Administration representatives.
12. To approve out of District training requested or required of the Commissioners, command staff, firefighters and District personnel.
13. To approve the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.0735 and §775.251.
14. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel.
15. To meet in Closed Session pursuant to Government Code §551.072 to deliberate real estate matters.
16. To meet in Closed Session, pursuant to Government Code §551.074, to discuss District personnel matters.
17. To discuss and act on District personnel matters including compensation, benefits, scheduling, retention, hiring and/or termination of District employees.
18. To review and approve submittals received from the District's Commissioners seeking compensation and reimbursements as permitted by Texas Health and Safety Code §775.038.

- 19. To discuss any new items which need to be on the agenda for subsequent District meetings and receive announcements by the Board or Department.
