8. Approve Audit for fiscal year ending 2024;
9. Operator's report, including:
 - (a) status of mapping of water line for lead and copper regulations;
 - (b) discuss residential and commercial deposits;
 - (c) authorization for termination of services to delinquent accounts.

- (a) status of developments;
- (b) status of Capital Improvement Plans;
- (c) authorize bids, change orders, or other project requirements as necessary;

11. Status on potential land sale/lease;

12. Attorney's report;


13. Such other matters as may come before the Board;


