3. Cinco Plant operations, discharge, repairs and maintenance, including update on RAS sludge pump no. 3 repair and annual CPI adjustment for Professional Services Contract with Si Environmental LLC.
4. Receive report of Engineer, including:
 - a. discuss 2024 Plant Capital Improvement Plan;
 - b. approve plans and specifications and authorize advertisement for bids for Plant electrical improvements and generator replacement;
 - c. pay estimates, change orders, substantial completion and final acceptance for trunk line sanitary sewer manhole rehabilitation, Phase 4;
 - d. approve plans and specifications and authorize advertisement for bids for trunk line sanitary sewer manhole rehabilitation, Phases 5 and 7;
 - e. pay estimates, change orders, substantial completion and final acceptance for trunk line sanitary sewer rehabilitation, Phases 5 and 7, including emergency repairs for collapsed line;
 - f. approve plans and specifications and authorize advertisement for bids for repairs to access road bridge wingwall and water line; and
 - g. Cinco Municipal Utility District No. 1 effluent reuse system, including update on construction of reclaimed water facilities.
