Notice is hereby given to all interested parties that the Council Members of the captioned Council will hold a public meeting by videoconference using Microsoft Teams and at 11450 Compaq Center Drive, Suite 660, Houston, Texas 77070. The public is invited to attend at that location, where a quorum of the Council will be present. A member of the Council present at that location will preside over the meeting. **Members of the public may also access the meeting by following the instructions listed at the bottom of this notice.**

The meeting will be held at **6:00 p.m. on Tuesday, February 11, 2025.** The subject of the meeting is to consider and act on the following:

1. Public Comment (1. Comments shall be limited to three (3) minutes per person; 2. By state law, comments by the Council members on any item not on the agenda shall be limited to: a) statements of specific factual information given in response to any inquiry; b) a recitation of existing policy in response to an inquiry; or c) a proposal to place the subject on the agenda for a future meeting. Section 551.042 of the Government Code limits the types of public comments that may be made and prohibits the Council from taking any action on the item except to place them on a future agenda.)
2. Approve Minutes of January 14, 2025 Meeting
3. Bookkeeper's Report and payment of bills; update on budget and investments; status of depository pledge agreements; amend budget, as necessary
4. Operator's Report; repairs and maintenance; other operations matters
5. Engineer's Report, including, but not limited to, items on the list below; authorize projects for advertisement for bids and award contracts; execute construction contracts, as necessary; approve pay applications; execute easements, as necessary
 - a. Construction update for WWTP Rehabilitation project
 - b. Construction update for Non-Potable Water Improvements
 - c. Harris County Hazardous Material Operation Permit Renewal
6. Such other matters as may come before the Council
