The Board will consider and act upon the following matters:

1. Consider comments and questions from District residents (3-minute limit);
2. Minutes of the meeting of 27 February 2023;
3. Security Report (Harris County Sheriff's Office) including:

  - (b) discuss proposed purchase of Flock Safety Security Camera System;


- (a) schedule meeting for review of Business Plan and Capital Improvements & Asset Utilization Plan;

11. Attorney's Report, including:

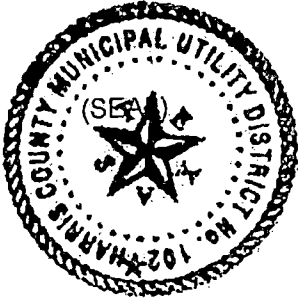
- (a) discussion regarding 5/6/23 Directors Election, including adopt Order Declaring Unopposed Candidates Elected to Office;

14. Schedule future meetings as required (next meeting on 24 April 2023).




