7. Review operator's report, discuss district operations and any appeals, consider approval of accounts to be written off, and take any necessary action;
8. Consider amendment to Rate Order and take any necessary action;
9. Consider approval of Interlocal Agreement with Harris Galveston Subsidence District for Water Wise Program and take any necessary action;
10. Review engineer's report, take any necessary action concerning on-going construction within the District, consider pay estimates, authorize additional construction bid advertisement if necessary, and if timely, award contracts on additional District improvements, consider any change orders, discuss engineering services, and take any necessary action in connection with engineering matters;
11. Consider adopting Resolution Concerning District Development Status for 2024 Tax Year and take any necessary action;
12. Consider approving Resolution Authorizing Use of Surplus Funds and take any necessary action;
13. Consider approving Order Calling Directors Election, Notice of Election, approving entering into an agreement with Harris County for election services and take any necessary action;

15. Discuss District communications, website and community events and take any necessary action; and




