

BAKER ROAD MUNICIPAL UTILITY DISTRICT NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas, said address being an office and meeting place of the District.

The meeting will be held on Tuesday, October 4, 2022, at 10:00 a.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 1. Public comments;
- 2. Review and approve minutes of the Board of Directors meeting held on September 6, 2022;
- 3. Conduct a public hearing regarding the adoption of the District's 2022 tax rate;
- 4. Levy of the District's 2022 debt service and maintenance tax rates, and the adoption of an Order in connection therewith;
- 5. Approval and execution of an Amended District Information Form;
- 6. Bookkeeper's report, including financial and investment reports and any actions required in connection therewith, and authorizing the payment of invoices presented;
