 - a. ditch maintenance and desilting projects, including update on V&C pipe repairs and priority list for additional repairs;
 - b. discussion of maintenance budgets and, if applicable, approval of any necessary proposals and/or budgets for regular, additional or revised maintenance schedules; and
 - c. update on Interlocal Mowing Reimbursement Agreement with Harris County Flood Control District for T-103 Channel.
5. Lake management and maintenance matters, including review proposals and authorize appropriate action.
6. Report from Inframark, LLC, including:
 - a. update on status of FEMA claim; and
 - b. maintenance of storm sewer lines, including approval of any necessary maintenance and repair proposals.
7. Engineering matters, including:
 - a. new drainage model and transfer of floodplain administrator duties, including related Interlocal Agreements with Harris County and Fort Bend County;
 - b. report on outfall inspections and rehabilitation plan and review maintenance chart and authorize appropriate action;
 - c. update on USACE Interim Study and authorize necessary action;
 - d. discuss financing of all desilting, repairs, and rehabilitation work due to Hurricane Harvey and authorize appropriate action, deeds, easements, offsite drainage agreements, consents, including requests to transfer drainage capacity and requests to reserve drainage capacity;
 - i. waterline easement across Va3;
 - e. design of District facilities;

- f. review bids and award contracts for construction projects;
 - g. status of ongoing improvements and repairs to District facilities, including approve pay estimate, change orders, substantial completion, and final acceptance and direct engineer to notify insurance company of new facility for the following:
 - i. Va1, Va9 and Va12 Slope Erosion;
 - ii. Central Green Improvements;
 - iii. Va3b silt removal and channel repair; and
 - iv. Va14-20 storm water outfall repairs and Va14-21W interceptor pipe replacement.
8. Phase II Small MS4 General Permit and Storm Water Management Plan, including:
 - a. status of compliance, necessary training, and public comment; and
 - b. Second Amendment to Storm Water Management Interlocal Cooperation Agreement, including legal conflicts waiver.
