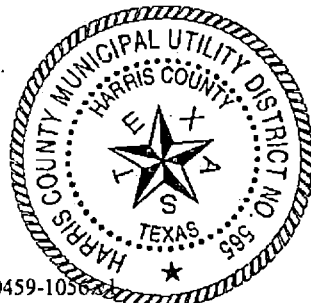

At the meeting the following items will be considered and acted on:

3. Discuss garbage rate CPI increase and consider taking any necessary action.
4. Hear NJ Services' Report and consider acting thereon, including:
 - a. Discuss and ratify repair/landscape proposals and take appropriate action.
5. Hear Financial Advisor's Report and consider acting thereon, including:
 - a. Approve Order Adopting Official Notice of Sale and Preliminary Official Statement for the District's Series 2024 Unlimited Tax Utility Bonds (the "Bonds");
 - b. Authorize advertisement of bids for the sale of the Bonds; and
 - c. Authorize Moody's indicative rating.
6. Authorize Auditor to prepare developer reimbursement audit for the Bonds.
7. Hear Bookkeeper's Report and consider acting thereon, including:

 - b. Authorize termination of water and sewer service to delinquent accounts;
 - c. Discuss Si Environmental contractual CPI increase and consider amending the Rate Order based on same.
10. Hear Engineer's Report and consider acting thereon, including:
 - a. Authorize the design of District facilities;
 - b. Approve plans and specifications for construction of District facilities;
 - c. Authorize advertisement for bids for District projects;
 - d. Approve pay estimates and change orders for construction projects in the District; and
 - e. Authorize and/or ratify construction contracts and related items.

12. Hear Attorney's Report and consider acting thereon.

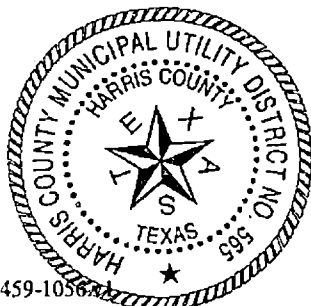


