TO THE QUALIFIED ELECTORS OF HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 170, AND TO ALL OTHER INTERESTED PERSONS:

Notice is hereby given that an election will be held on the 1st day of May, 2021, between the hours of 7:00 a.m. and 7:00 p.m., at the locations listed in Attachment B, for the purpose of voting upon the following proposition:

PROPOSITION A

SHALL THE BOARD OF DIRECTORS OF HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 170 OF HARRIS COUNTY, TEXAS, BE AUTHORIZED TO ISSUE THE BONDS OF SAID DISTRICT IN ONE OR MORE ISSUES OR SERIES IN THE MAXIMUM PRINCIPAL AMOUNT OF \$11,535,000 MATURING SERIALLY OR OTHERWISE IN SUCH INSTALLMENTS AS ARE FIXED BY SAID BOARD OVER A PERIOD OR PERIODS NOT EXCEEDING THE MAXIMUM NUMBER OF YEARS AUTHORIZED BY LAW FROM THEIR DATE OR DATES, BEARING INTEREST AT ANY RATE OR RATES, AND TO SELL SAID BONDS AT ANY PRICE OR PRICES, PROVIDED THAT THE NET EFFECTIVE INTEREST RATE, AS DEFINED BY CHAPTER 1204, TEXAS GOVERNMENT CODE, AS AMENDED, ON ANY ISSUE OR SERIES OF SAID BONDS SHALL NOT EXCEED THE MAXIMUM LEGAL LIMIT IN EFFECT AT THE TIME OF ISSUANCE OF EACH SUCH ISSUE OR SERIES, ALL AS MAY BE DETERMINED BY THE BOARD OF DIRECTORS OF SAID DISTRICT, FOR THE PURPOSE OR PURPOSES OF PURCHASING, CONSTRUCTING, ACQUIRING, OWNING, LEASING OR OPERATING A WATERWORKS SYSTEM, A SURFACE WATER SYSTEM, A SANITARY SEWER SYSTEM, AND A DRAINAGE AND STORM SEWER SYSTEM FOR SAID DISTRICT, AND ADDITIONS, EXTENSIONS, AND IMPROVEMENTS THERETO, AND PURCHASING OR OTHERWISE ACQUIRING ANY AND ALL PROPERTY, CONTRACT RIGHTS, RIGHTS OF USE, AND INTERESTS IN PROPERTY NECESSARY, APPROPRIATE, OR INCIDENT TO THE PURCHASE, CONSTRUCTION, ACQUISITION, OWNERSHIP, LEASING, OR OPERATION OF SUCH WATERWORKS SYSTEM, SURFACE WATER SYSTEM, SANITARY SEWER SYSTEM, AND DRAINAGE AND STORM SEWER SYSTEM, AND ADDITIONS, EXTENSIONS, AND IMPROVEMENTS THERETO, AND FOR THE ADDITIONAL PURPOSE OF PAYING ALL EXPENSES IN ANY MANNER INCIDENTAL THERETO, AND SUCH EXPENSES AS ARE INCIDENTAL TO THE ORGANIZATION, ADMINISTRATION, AND FINANCING OF THE DISTRICT WHICH UNDER APPLICABLE LAW MAY PROPERLY BE PAID FROM THE PROCEEDS OF SUCH BONDS; AND TO PROVIDE FOR THE PAYMENT OF PRINCIPAL OF AND INTEREST ON SUCH BONDS BY THE LEVY AND COLLECTION OF A SUFFICIENT TAX UPON ALL TAXABLE PROPERTY WITHIN SAID DISTRICT, ALL AS AUTHORIZED BY THE CONSTITUTION AND LAWS OF THE STATE OF TEXAS, INCLUDING PARTICULARLY (BUT NOT BY WAY OF LIMITATION) CHAPTERS 49 AND 54 OF THE TEXAS WATER CODE, TO THE EXTENT APPLICABLE, TOGETHER WITH ALL AMENDMENTS AND ADDITIONS THERETO; SAID BONDS, IF AUTHORIZED, TO BE ISSUED IN ADDITION TO THE REMAINING \$5,000 AUTHORIZED BUT UNISSUED UNLIMITED TAX BONDS APPROVED PURSUANT TO THE ELECTIONS HELD ON AUGUST 9, 1980, APRIL 4, 1981, AND SEPTEMBER 9, 1989; PROVIDED THAT IF THIS PROPOSITION IS NOT APPROVED, THE DISTRICT SHALL CONTINUE TO BE AUTHORIZED TO ISSUE THE REMAINING \$5,000

AUTHORIZED BUT UNISSUED UNLIMITED TAX BONDS APPROVED
PURSUANT TO THE ELECTIONS HELD AUGUST 9, 1980, APRIL 4, 1981, AND
SEPTEMBER 9, 1989, WITH SUCH BONDS VALIDATED AND REAUTHORIZED
TO BE ISSUED?

In accordance with Section 1251.052(b) of the Texas Government Code, as amended, the Board is not required to prepare a voter information document for the above proposition, as the District has less than 250 registered voters as of the date the District ordered the election.

The election is being held pursuant to an order adopted by the Board of Directors of the District on February 3, 2021, a copy of which is available in the office of the District at 1980 Post Oak Boulevard, Suite 1380, Houston, Texas. The Harris County Election Administrator shall appoint the presiding judge and clerks. The early voting ballot board shall be appointed by the Harris County Election Administrator.

The clerk for early voting shall be the Harris County Election Administrator, and the places at which such early voting shall be conducted are listed in Attachment B attached hereto. The early voting clerk's email address at which the early voting clerk may receive applications for ballot by mail is BBM@cco.hctx.net. The early voting clerk's mailing address to which ballot applications and ballots to be voted by mail shall be sent is: Elections Administrator of Harris County, 1001 Preston, 4th Floor, Room 439, Houston, Texas 77002.

Early voting by personal appearance shall occur on each day beginning Monday, April 19, 2021, through Tuesday, April 27, 2021, that is not an official State holiday. The early voting schedule shall be between the hours and at the locations listed in Attachment A.
