1. Public communication and comments – no formal Board action will be taken;
2. Confirm appointment by the City of Houston of directors, qualify directors and confirm receipt of Statement of Officer forms and administer Oaths of Office;
3. Elect Officers;
4. Review of actions taken at the February 8, 2021 organizational Board meeting and approve Minutes of February 8, 2021 organizational meeting;
5. If timely, consider and approve the engagement of Hawes Hill and Associates, LLP to provide Board and PID Management services and execute related agreement;
6. Brief confirmation of the status of the upcoming May 1, 2021 elections and set date for next meeting to canvass such elections;
7. Consider engagement of Municipal Accounts and Consultant, LP as bookkeeper for the District and approve Bookkeeping Services Agreement;
8. Consider and approve the opening of District bank accounts at Prosperity Bank and authorization execution of related resolutions and signature cards;
9. Authorize negotiations with AUC Group with respect to a review of lease operations and other lease water and wastewater service available to the District and, if timely, approve form of related agreement(s) and execute agreement(s) for the District and for any land additions added to the District as each relevant agreement is finalized by the District's attorneys;
10. Consider, approve and authorize execution of the Construction, Funding, and Acquisition Agreements ("Reimbursement Agreements") with 133 Lone Wolf, Ltd. ("Lone Wolf");

11. Authorize preparation by the District's consultants, execution by its attorney and submission of Water District Consent Applications, when timely, to the City of Houston in connection with the Lone Wolf land in the District;
12. Authorize preparation by the District's consultants, execution by its attorney and submission of Water District Consent Applications, when timely, to the City of Houston in connection with any authorized annexations of land to the District; and
13. Adjournment.


