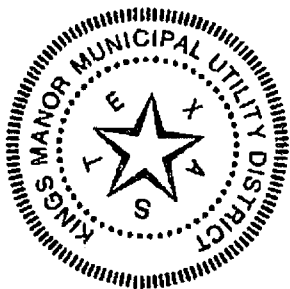
**KINGS MANOR MUNICIPAL UTILITY DISTRICT
