NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District.

The meeting will be held on Tuesday, July 16, 2024, at 5:30 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

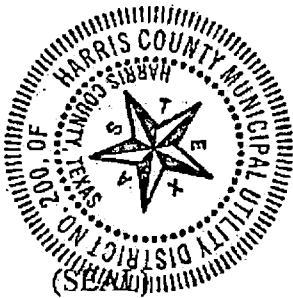
1. Public comments;
2. Acceptance of Qualification Statements, Bonds, Oaths of Office and Affidavits of Current Director, and Elections Not to Disclose Certain Information for new director;
3. Election of officers of Board of Directors;
4. Approval of District Registration Form relative to election of Directors;
5. Authorize update to local government officers list in connection with conflict of interest disclosure requirements;
6. Discuss training requirements for Directors pursuant to the Texas Open Meetings Act and the Texas Public Information Act, and the procedures for compliance with same;
7. Discuss conflicts disclosure statement reporting requirements memorandum for Directors;
8. Review and approve the minutes of June 18, 2024, Board of Directors meeting;
9. Harris County Constable's Office Security Report, including security issues within the District;
10. Approval of Interlocal Agreement for Law Enforcement Services between the District and Harris County, Texas;
11. Bookkeeper's report, including financial investment reports, and authorizing the payment of invoices presented;

12. Tax Assessor-Collector report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
13. Report and legal action taken by the District's delinquent tax collections attorney, authorize foreclosure proceedings, installment agreements, the filing of proofs of claim and approval of service terminations;
14. Operation and maintenance report, including:
 - (a) Authorizing the repair and maintenance of District facilities;
 - (b) Any appeals of District charges; and
 - (c) Approve write-off of uncollectible accounts, including report concerning year to date total for uncollectable accounts;
15. Engineering report, including:
 - (a) Authorizing the design, advertisement for or solicitation of bids and/or award of construction contracts or concurrence in the award of a contract for the construction and/or repair of water, sanitary sewer and drainage facilities within the District; status of construction contracts, including the approval of any change orders; and/or acceptance of facilities for operation and maintenance purposes and acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, including:
 - (i) Water Plant No. 1 HPT Nos. 1 and 2 Replacement – CFG Industries;
 - (ii) Wastewater Treatment Plant Rehabilitation; and
 - (iii) Emergency Water Well Repairs;
 - (b) Discussion regarding E. Coli monitoring;
 - (c) Discussion regarding tests being conducted to determine the arsenic and iron levels in the District's water supply;
 - (d) Wastewater Treatment Plant, including proposal for platting;
 - (e) Status of TPDES Major Permit Amendment;
 - (f) Status of Annual Water Plant Inspections; and
 - (g) Status of Feasibility Study for Temporary Wastewater Capacity for Harris County Municipal Utility District No. 58;
16. Status of Fifth Addendum and Amendment to Waste Disposal Contract between the District and Harris County Municipal Utility District No. 215;
17. Status of preparation of Bond Application Report No. 10, and consider adoption of Order Authorizing Application to the Texas Commission on Environmental Quality for Approval of Project and Bonds and for Use of Surplus Funds and Interest Earned on Construction Funds;
18. Issuance of utility commitments;
19. Matters related to the Central Harris County Regional Water Authority;

20. Communications Report, including discussion regarding website and messaging services, and take any action necessary and appropriate in connection therewith;
21. Review Memorandum regarding Electronic Storage of District Records; adoption of Resolution Adopting Records Retention Schedules and Policies and Procedures for Electronic Storage of District Records;
22. Request from Records Management Officer to destroy certain records of the District;
23. Discussion regarding debris collection, and take any action necessary or appropriate in connection therewith;

25. Convene executive session pursuant to Open Meetings Act, Texas Government Code Section 551.071 (consultation with attorney), and/or Section 551.072 (acquisition of real property or interests therein);
26. Reconvene in open session; authorize the taking of any action resulting from deliberations in executive session; and
