  - c. Approve Paying Agent/Registrar Agreement;
  - d. Approve Official Statement;

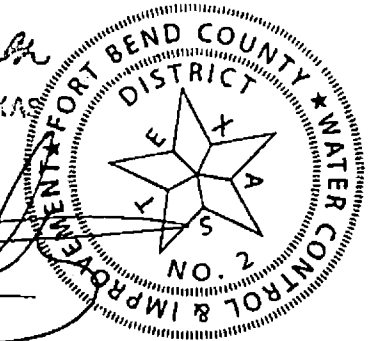
