

Government Code, Chapter 551, the Board of Directors (the "Board") of Harris County Municipal Utility District No. 44 will meet in regular session, open to the public, at 4:00 p.m., on Tuesday, February 11, 2025, at 15705 North Greenfield Drive, Spring, Harris County, Texas 77379, a designated meeting place of the Board outside the boundaries of the District, at which meeting the following items will be considered:


- 1. Hear from the public.
- 2. Approval of minutes of January 14, 2025.
- 3. Tax Assessor/Collector's Report and consider taking action thereon, including:
 - A. Approval of report and authorize payment of invoices from tax account.
- 4. Bookkeeper's report and consider taking action thereon, including:
 - A. Approval of report and bills submitted to the District for payment
 - B. Review Investment Report/Collateral Pledge Agreement and authorize necessary action relating thereto.
- 5. Operator's Report and consider taking action thereon, including:
 - A. Authorization of termination of water and sewer service to delinquent accounts.
 - B. Authorization of necessary repairs and maintenance.
- 6. Engineer's Report and consider taking action thereon, including:
 - A. Consider requests for water/sewer service/annexation and take action related thereto.
 - B. Report on North Harris County Regional Water Authority and authorize necessary action in connection therewith.
 - C. Report on repairs to Wastewater Treatment Plant and authorize necessary action in connection therewith.
 - D. Report on construction projects, including authorization of advertisement of bids, award of contracts, approval of pay estimates and change orders.
 - E. Review and take action on Capital Projects Plan.
- 7. Attorney's Report, discuss and take action on trash contract, Approve Resolution Regarding Tax Exemptions, engage Attorney to collect delinquent taxes; adopt Order Imposing 20% Penalty on Delinquent Taxes, and approve rate increase with Off Cinco,
- 8. Report on Green Medians Committee and take necessary action related thereto.
