- 9. Engineer's Report and consider taking action thereon, including:

  - B. Report on North Harris County Regional Water Authority and authorize necessary action in connection therewith.
  - C. Report on repairs to Wastewater Treatment Plant and authorize necessary action in connection therewith.
  - D. Report on construction projects, including authorization of advertisement of bids, award of contracts, approval of pay estimates and change orders.
  - E. Review and take action on Capital Projects Plan.
- 10. Attorney's Report, including approval of Resolution Authorizing Emergency Action Plan.
- 11. Report on Green Medians Committee and take necessary action related thereto.
