
Notice is hereby given pursuant to V.T.C.A., Government Code Section 551, that the Board of Directors of Harris County Water Control and Improvement District No. 92 will meet in special session, open to the public, at 2:00 p.m. on Monday, October 7, 2024 at 1911 Bellchase, Spring, Texas, a meeting place inside the District, at which meeting the following items will be considered:

1. **Hear from Public.**  
*The District has adopted a policy regarding public comment. A copy of this policy will be available at the meeting. All those wishing to address the Board during the public comment period shall indicate a desire to address the Board on the applicable sign-in sheets. Public comments are limited to three (3) minutes per person for a total of thirty (30) minutes.*
2. **Conduct Public Hearing on 2024 Tax Rate.**
3. **Adopt Order Setting 2024 Tax Rate.**
4. **Amend Notice to Sellers and Purchasers and authorize recordation of same.**
5. **Constable's report and consider taking any action recommended.**
6. **Receive report from Best Trash garbage collection and consider taking any action recommended.**
7. **Receive Bookkeeper's report, authorize payment of bills and consider taking any action requested by the Bookkeeper, including:**
  - a.) Discuss budget and consider taking any action recommended.
8. **Approve minutes of prior meetings.**
9. **Receive Operator's Report and consider taking any action requested by the Operator.**
10. **Discuss Rate Order and amend if necessary.**
11. **Receive Recreation Advisory Committee report, including: discuss park budget and project priorities, and consider taking necessary action related thereto.**
12. **Receive Engineer's report and consider taking any action requested by the Engineer including:**
  - a.) Approval or report, pay estimates, and change orders for construction projects in progress in the District.
13. **Receive reports from officers and consider taking any action requested, including:**
  - a.) Discuss what actions, if any, should be taken regarding the projected timeline for the provision surface water by NHCRWA and consider authorizing the same.
14. **Receive General Manager's report and consider taking any action requested by General Manager, including:**
  - a.) Discuss, approve, and authorize execution of pool management contract.
15. **Discuss and set regular meeting dates for November and December.**

Pursuant to V.T.C.A. Government Code, Chapter 551, as amended, the Board of Directors may convene in closed session to receive advice from legal counsel and discuss matters relating to pending or contemplated litigation, personnel matters, real estate transactions, gifts and donations, security devices and/or economic development negotiations.
