NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas, said address being a meeting place of the District.

The meeting will be held on Wednesday, October 5, 2022, at 12:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public comments;
2. Approve the minutes of the September 7, 2022, Board of Directors meeting;
3. Conduct a public hearing regarding the adoption of the District's 2022 tax rate;
4. Levy of the District's 2022 debt service and maintenance tax rates, and the adoption of an Order in connection therewith;
5. Approval and execution of an Amended District Information Form;
6. Tax Assessor-Collector report, including authorize payment of invoices presented, approving moving of accounts to uncollectible roll, status of collection of delinquent taxes, including authorizing lawsuit and/or foreclosure, as appropriate;
7. Receive the Financial Advisor's recommendation concerning the District's proposed 2022 tax rate, determine intended tax rate, and authorize:
 - a. the required notice that the Board will consider adoption of a tax rate; and
 - b. the means of providing such notice;
8. Report and legal action taken by the District's delinquent tax collections attorney, and take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
9. Bookkeeper's report, including financial and investment reports, and the authorization of the payment of invoices presented;
10. Report by Champions Hydro-Lawn, Inc. regarding maintenance of detention and drainage facilities; proposals and any related Texas Ethics Commission ("TEC") Form 1295s;

11. Security patrol report, including consider contracting additional deputies with Harris County Sheriff's Office;
12. Operator's report, including:
 - a. Consider appeals of District charges; status of delinquent accounts;
 - b. Consider authorizing the repair and maintenance of District facilities, and authorize acceptance of TEC Form 1295, as applicable, refer accounts to collection and approve write-off of uncollectible accounts; and
 - c. Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
13. Engineer's Report, including:
 - a. Authorizing the design and/or advertisement for bids for the construction of facilities within the District, and authorize acceptance of TEC Form 1295, and approving of related storm water plans;
 - b. Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, and authorize acceptance of TEC Form 1295, and approval of any related storm water permits;
 - c. Status of construction of facilities to serve land within the District, including the approval of any change orders, and authorize acceptance of TEC Form 1295;
 - (i) Lakeview Haven Drive Extension Project, including paving, sanitary sewer facilities, drainage facilities, and beautification;
 - (ii) Extension of sidewalks to hike and bike trail around drainage channel (Sommerall Park HOA request);
 - (iii) Installation of Generator at Water Plant; and
 - (iv) Joint Wastewater Treatment Plant Replacement project with Harris County Municipal Utility District No. 149 ("No. 149");
 - d. Northwest Harris County Municipal Utility District No. 16's Wastewater Treatment Plant Rehabilitation project;
 - e. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes, including:
 - (i) Storm Sewer and Drainage Easement (0.4397 acre) from ASP Partnership;
 - f. Status of street and storm sewer acceptances by Harris County;
 - g. Updates to Capital Improvements Plan; and
 - h. Utility commitment requests;
14. Developers' reports, including:
 - a. Status of feasibility study for development of ASP Tract;
15. Attorney's report, including:
 - a. Status of matter regarding payments for joint Water Plant and Wastewater Treatment Plant with No. 149;

16. Closed Session pursuant to Open Meetings Act, Texas Government Code, Section 551.071 to consult with the District's attorney regarding matters protected by attorney-client privilege;
17. Reconvene in Open Session and authorize any action resulting from matters discussed in Closed Session; and
18. Matters for possible placement on future agendas.
